Business start-ups: Assuria Ltd



- Assuria Ltd is an IT security software developer, providing automated compliance and information assurance solutions to protect corporate and customer information assets from the threat of corruption, theft, abuse and poor controls, especially from 'Insiders'.
- As a start-up business Assuria required a flexible tenancy agreement.
- The Science and Technology Centre (STC) and the Reading Enterprise Centre, located on the University of Reading campus, offer prime opportunities for entrepreneurial companies to develop and grow.
- The STC comprises approximately 3,000 square metres of lettable space, divided between office and laboratory space, and offers an excellent environment for companies in the chemical, biological or environmental sectors who seek R&D facilities.
- Business advice was provided by the Enterprise Hub - now called South East Business Innovation and Growth
- Assuria have been based at the STC for four years and have benefitted from the flexibility and price of the leasing terms as well as interaction with both other SMEs and students.

Background information


After visiting business advisors at the Enterprise Hub (EH) * and Reading Enterprise Centre (REC) at the University of Reading in mid 2004, the directors of Assuria remembered its benefits when considering commercial premises for their new company.

The recent start-up company had been looking for premises with flexible terms in contrast to the usual commercial properties on offer. Assuria was attracted to the REC in terms of its flexibility which meant that it could sign a 'tenancy at will' agreement. Starting with just one room Assuria could expand and grow as and when necessary.

After a couple of years Assuria required more space and moved from the Reading Enterprise Centre (REC) to the Science and Technology Centre (STC), still within the University of Reading campus. The interaction and shared sense of community with other SMEs at the REC and the STC was a key attraction for Assuria. The company even benefitted from the skills of an employee from a fellow tenant company for a short period.

Interactions with the University

In the summer of 2006 Assuria participated in the Shell Step Programme, a student placement scheme. Assuria benefitted from two successful projects with students from the University of Reading. One of these was selected as a runner up in the regional final of the Shell Step programme awards.



Assuria are currently in discussions with several academics at the University about possible research projects.

The flexibility of their leasing terms ensure that tenants have the ability to expand and grow the business on site.
