SECURITY: Organisations which process sensitive and confidential information in their everyday business dealings face conflicting pressures to keep this data secure and yet to allow access by authorised users and applications. COMPLIANCE: Increasing regulatory enforcement by Central Banks and Industry Regulators worldwide is a fact of business life, but achieving compliance within the IT infrastructure need not be a huge overhead for IT departments if automated compliance solutions are employed in this area. Assuria compliance assessment solutions assist organisations to quickly assess their IT Infrastructure and to rapidly bring systems up to a compliant state, and crucially, through automatic monitoring to maintain that compliance on an ongoing basis.

AUDITING: A mandatory element of all major regulatory standards is the creation of secure audit trails from all business processes that handle sensitive or critical information. Produced by harvesting event logs from all critical systems, applications and devices within an IT Infrastructure, these audit trails allow subsequent forensic analysis and investigation in case of suspected security breaches. Assuria solutions reinforce audit control settings to ensure that event logging is active, and then automatically collect and securely store these forensically sound logs in a central location. Powerful dashboard, analysis and reporting features provide summary and detailed reports on a range of security and operations related events and patterns.

MONITORING: Once systems are configured according to required policy, with all applications and data files in a known and trusted state and security and operational controls are fully active, what happens when configuration changes occur (such as a user being granted superuser privilege)? Two key questions need to be answered at this point. Firstly, is the change authorised at the appropriate level? And secondly, does the change take a system out of compliance? Assuria configuration change detection and event monitoring solutions provide visibility and alerting of such changes through monitoring system event logs for specific events and by comparing configurations against known baselines.
